

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.oilsfirstblog.com and Oils First and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Oils First include www.oilsfirstblog.com, www.oils1st.com and www.oilsfirst.com. The Oils First website is a news and information site. By using the Oils First website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Oils First may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

If you purchase Oils First's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Oils First collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Oils First may also use your personally identifiable information to inform you of other products or services available from Oils First and its affiliates.

Sharing Information with Third Parties

Oils First does not sell, rent or lease its customer lists to third parties.

Oils First may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Oils First may share data with trusted partners to help perform statistical analysis, send you email or

postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Oils First, and they are required to maintain the confidentiality of your information.

Oils First may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Oils First or the site; (b) protect and defend the rights or property of Oils First; and/or (c) act under exigent circumstances to protect the personal safety of users of Oils First, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Oils First. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Oils First website.

Use of Cookies

The Oils First website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Oils First pages, or register with Oils First site or services, a cookie helps Oils First to recall your specific information on subsequent visits.
